The Privacy Policy

This Privacy Policy governs the manner in which Vescom Sp. Z o.o. Sp. Personal identification information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal

We may use third party service providers to help us operate our business and the App or administer activities on our behalf, such as sending out newsletters or surveys.

Third party websites

Advertising

Ads appearing on our App may be delivered to Users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile non personal identification information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you

Compliance with children's online privacy protection act

Protecting the privacy of the very young is especially important. For that reason, we try never collect or maintain information at our App from those we actually know are under 13, and no part of our website is structured to attract anyone under 13.

Third Party Services

Our websites and products may contain advertising or third party services (such as the Facebook Like button or links to third-party websites). If you click on those links, including an advertisement, you will leave the Distorted App and go to the site you selected.
